

Product description

The Insert Megalet is a contoured integrally reinforced insert branch connection

Insert Megalets features:

- Fully interpretable radiographic or ultrasonic weld examination
- Longer life under cyclic fatigue loading
- Butt-weld installation in header pipe
- Outlets available in butt-weld, socket-weld, threaded and flanged configurations
- Shape in compliance with Figure 328.5.4E or K328.5.4 of ASME B31.3
- Low stress intensification (SIF)




Recommended installation procedure*

The Insert Megalet is an insert type fitting.

For the fitting installation, operators need a template to guide them in cutting the hole.

For the majority of installations, the Insert Megalet itself can be used as a template.

Due to manufacturing tolerances and pipe tolerances, the installation hole should not be cut until the installer has the template or the actual Insert Megalet to be installed.



- 1. Locate the center of the hole to be cut on the pipe.
- 2. Locate the Insert Megalet on that center and trace around the outside.
- 3. Remove the Insert Megalet and cut the hole. (It is recommended to cut on the inside of the guide line, as additional cutting and grinding will be required to produce the appropriate weld bevel and size for the root gap to match your weld procedure).
- 4. Perform the additional work to achieve clean metal and appropriate weld preparation for your WPS.
- 5. Locate the Insert Megalet in the prepared hole. (It is recommended to use wedges).
- 6. When properly located, it is ready to tack and weld out as per you WPS.
